SUBJECT: Grand Joint Exercise No. 4 to be held in Hawaii, 1932.

Reference: (a) Statement of Grand Joint Exercise No. 4.

1. Statement of problem to be known as "Grand Joint Exercise No. 4, to be held in Hawaii, 1932", was drawn up by the Joint Board and approved by the Acting Secretary of War on April 27, 1931, and by the Secretary of the Navy on April 24, 1931.

2. Grand Joint Exercise No. 4 will be held in and about Hawaii on the occasion of the visit of a major portion of the United States Fleet to Hawaii during 1932.

3. Detail of Umpires (Navy).

Referring to paragraph 14 (a) of reference (a), the following designation of Umpires is effective:

> Chief Umpire, U.S.Navy: Commander in Chief, U.S. Fleet.

Assistant to Chief Umpire, U. S. Navy: Member of Staff, U. S. Naval War College, designated by the President, U. S. Naval War College.

Senior Umpire BLUE, U. S. Navy:

Representative of the General Board, designated by the President of the General Board.

Representative of the War Plans Division, Office of the Chief of Naval Operations, designated by the Director, War Plans Division.

Assistant to Senior Umpire BLUE, U. S. Navy:

One Marine Corps officer of field rank, designated by the Major General Commandant, U.S.M.C.

Assistant to Senior Umpire BLACK, U.S.Navy:

One naval officer attached to the 14th Naval District, designated by the Commandant, 14th Naval District.

4. Command.

(a) In accordance with the provisions of paragraph 6(a) of reference (a), the Commander, Battle Force, will command BLUE Forces in Grand Joint Exercise No. 4.

(b) The War Department has designated Major General Malin Craig, Commanding General, Ninth Corps Area, as the Commanding General, BLUE Expeditionary Forces.

(c) The Commander of the Marine Corps Expeditionary Force which will accompany BLUE Forces will be designated by the Major General Commandant, U.S.Marine Corps.

(d) The Commandant of the 14th Naval District will command BLACK Naval Forces. This action is taken in view of the character of the operations contemplated by Grand Joint Exercise No. 4. These operations for the BLACK Naval Forces are in the main essentially those of Local Defense.
